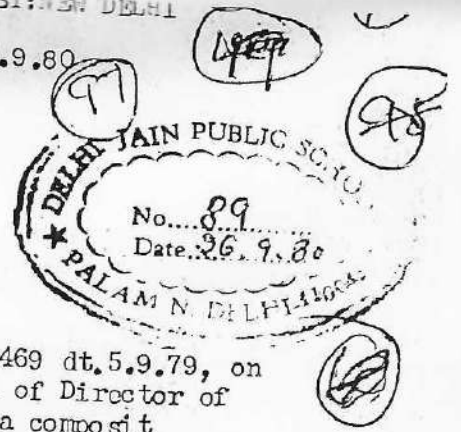

Sir,

With reference to your letter No. DIPS/43-79-1469 dt. 5.9.79, on the above subject, I am directed to convey the approval of Director of Education, Delhi, to the recognition of your school as a composite un-aided Middle School for Class I to VIII with effect from 1.5.80 on the following conditions :-

1. That the school will admit students without any discriminations of caste and creed.
2. The school will abide by the rules and regulations of D.S.E. Act/rule 1973, and instructions issued thereunder time to time.
3. Fee concession will be allowed to deserving students under the rules.
4. The school will appoint ~~only~~ only qualified teacher within prescribed age limit.
5. The teaching and other staff of the school will be paid pay and allowance at par with those in Govt. schools.
6. The school will follow the syllabus /books prescribed by the Dte. of Edns.
7. The school will add books for Rs. 3000/- with the existing school library by 31.12.80.
8. The management will not terminate the services of any staff members, without obtaining the ~~proper~~ permissions of the Dte. of Edn.
10. The school will furnish the information vide rule 180(2) of DSEA 1973.
11. The management will transfer the reserve fund in the joint name of the Manager of the School & the D. E. Delhi immediately.
12. The management will not utilise any portion of school premises for any purpose other than Education activities.
13. The management will build ~~the~~ the building for the school as its own.
14. The management will not ~~xxxx~~ enhance the fees, without prior approval of the Deptt.
15. The management will not use the school as an instrument for the interest of one family.

Sir,

With reference to your application on the subject cited above, approval for the upgradation of the existing Middle School to Secondary level (without aid) is granted with effect from 1985-86 session subject to the fulfilment of the following terms and conditions:-

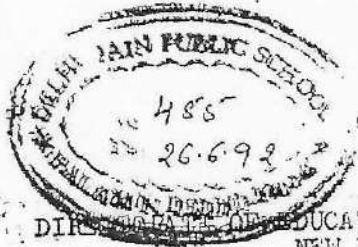
1. That the school shall abide by the provision of Delhi School Education Act and Rules framed thereunder as well as the instructions issued from time to time.
2. That the school shall admit students without any discrimination of caste and creed.
3. That the school shall appoint full time qualified and eligible staff for all the classes of the school as per the present norms of the Department. Additional staff shall be provided for Secondary classes immediately.
4. That the school shall equip the Science Labs as per the norms of the Department and suitable facilities for practical work shall be provided to the students.
5. That a proper library shall be established and facilities for reading room shall also be made available for students as well as teachers. Books as per the ratio of 10 books per student shall be provided.
6. That adequate sports material shall be purchased and made available to the students immediately.
7. That the school shall strictly abide by the provisions of Sec.10(i) of the Delhi School Edn. Act & Rules, 1973.
8. That the enrolment in section shall not exceed the number of students calculated @ 12 sq.ft. per student for the available floor area of the classroom and the school shall provide adequate and sufficient accommodation as per the norms of the Directorate of Education, Delhi in each class. Number of sections should not exceed the number of existing classrooms of proper size in the school.
9. That the school shall not run any unrecognised classes or any other activities within the school premises and all the recognised classes shall be run at one place at the above address only. Nursery class be removed from the premises of the school, if any.

Sir,

With reference to your application on the subject cited above I am directed to convey the approval of the Director of Education, Delhi for the upgradation of the existing SECONDARY School to SR. Secondary school level (Sc., Arts & Commerce) without aid w.e.f. 92-93 session subject to the fulfilment of the following terms and conditions:

1. That the school shall abide by the provision of DSEA & Rules 73 framed thereunder as well as the instructions issued from time to time.
2. That the school shall admit students without any discrimination of caste and creed.
3. That the school shall meet the additional liability of SR. Secondary classes.
4. That a proper library shall be established and facilities for reading room shall also be made available for students as well as teachers. Books as per the ratio of 10 books per student shall be purchased and made available to the students.
5. The adequate sports material shall be purchased and made available to the students.
6. That the school shall strictly abide by the Provisions of section 10'1' of the DSEA & Rules 73.
7. That the school shall not run any unrecognised classes or any other activities within the school premises and all the unrecognised classes shall be run at one place at the premises of the school immediately.
8. That the school shall dispense with the service of unqualified and over aged staff, if any immediately.
That the service contract between the Management and the employees shall be executed immediately.
10. Fresh Health certificate from MCD be obtained & produced to EO for verification.

10. That the school shall dispense with the services of unqualified and overaged staff, if any, immediately.
11. That the scheme of management shall be got approved from the Department immediately.
12. That the service contract between the management and the employees shall be executed immediately.
13. That all facilities prescribed under the Rules 50 & 51 of the DSER, 1973 shall be made available to the students and rules 6, 7, 8 and 9 may be observed strictly.
14. That the arrangements for good drinking water shall be made available to the students as well as to the teachers and sanitary facilities shall also be provided to the students adequately. Health Certificate may be obtained from the local body within a month.
15. That the management of the school shall create a reserve fund of Rs.15,000/- (Rupees Fifteen Thousand Only).
16. That the violation of any instructions/orders/conditions/rules and regulations of the Department shall lead to the withdrawal of the recognition of the school. Conditions imposed earlier may also be fulfilled.
17. That the management of the school shall not appoint any new teacher and will not give any promotion to the teachers without taking the prior permission of the Directorate of Education.
18. That the management of the school shall immediately apply for affiliation with Secretary, CBSE for affiliation through Education Officer concerned.
19. That no demand for Grant-In Aid shall be made by the school management for the Secondary classes till the ban on creation of posts/recruitment of posts exists.
20. That class-IX may only be added during this academic session i.e. 1985-86.
21. That a report about the fulfilment of the above conditions giving the extent to which each condition is fulfilled, shall be sent to Education Officer every six month.
